ROUTES TO THE SHOW SITE

*** Please note*** - Even though the facility has a Campbell Rd address, the building is closer to Blalock.

Please note - There is extensive construction on 290. If coming from that direction, allow extra time to arrive. Updates can be found at <http://www.my290.com/>

From I-10, go North on Blalock, cross Westview, Long Point, Hammerly, & Emnora. Take first "U-turn" heading back toward Emnora, turn right into parking lot before Emnora light. First building on the right. Distance is approximately 2 ½ miles from I-10. Facility is about 2 ½ miles east of W. Sam Houston Parkway N.

From Hwy 290, go South on Fairbanks N. Houston. This street turns into Blalock after passing Hempstead Hwy. Cross Clay & Kempwood. Turn right into parking lot right before Emnora. First building on the right. Distance is approximately 3+ miles from Hwy 290. Facility is about 2 ½ miles east of W. Sam Houston Parkway N.

If using GPS, enter 2401 Blalock Houston TX
